Abante's veins going to the heart that needs for audiogram which cost large amount of money (P60,000.00) to determine what veins have an obstruction

then angioplasty which cost a hundred thousand to take off the obstruction in the vein. Bro. Abante said to the Cardiologist that they don't have that much money, instead, he ask the doctor to prescribe him medicine to dissolve the obstruction in his vein going to the heart with faith according to Bro. Abante. The doctor prescribed him medicine but still saying to bro. Abante if he able to produce the amount needed for audiogram just call her. But Bro. Abante have faith that the obstruction will be dissolve by the medicine prescribed and God honor his faith because as he take the medicine he feel better and he able to work hard now and feeling better no longer feel the numbness on his left arm and no hard breathing anymore. Bro. Abante's Cardiologist surprise with the result of Bro. Abante's treatment and he will not longer undergo audiogram. Praise the Lord!
